### TERMS AND CONDITIONS OF THE INITIATIVE



The Basque Country Technology Park is launching another open innovation initiative to generate ideas that could help to improve the Park, the companies based there and the people who work there.

#### **SCOPE OF THE CHALLENGE**

Ideas that will allow the Park to develop its 2025-2028 Strategic Plan for the future, in line with new challenges.

#### Download the 2021-2024 Strategic Plan

- Impact on the Technology Park community:
  - Improvements in the quality of life of employees.
  - Encouragement of collaboration between companies based in the park.

#### • Optimisation of infrastructures and services:

- Improvements to workspaces or common areas (indoors and/or outdoors within the development).
- Proposals related to energy efficiency and managing resources in infrastructures
- Proposals related to improving existing services and implementing new services.

#### • Innovation in processes and technologies:

- Introducing emerging technologies to benefit the companies based there.
- Digital management and communication solutions within the park.

#### • Sustainability and environment:

- Projects related to improving sustainability on the various campuses (renewable energies, consumption, resilience to climate change, circular economy, emissions...).
- Proposals related to sustainable mobility within the various campuses.

#### • Business development and competitiveness:

 Ideas that could lead to new business opportunities for companies in the Park with other companies in the Park itself or with companies in the surrounding area.

#### TARGET AUDIENCE

The target audience of this initiative are **people who work at companies** based at the different campuses of the Basque Country Technology Park who want to propose ideas aimed at improving the Park.

#### PRIZES

**ONE CHALLENGE** will be rewarded out of all the challenges proposed in this call for entries.

There will be a prize on offer for individuals and companies that take part:

**INDIVIDUAL PRIZE**: the winner of this edition will win **a travel bag** worth 600 euros.

**COMPANY PRIZE**: the company where the winner works will receive **1 day's use free of charge** of one of the **creativity rooms** located in one of the central buildings on the Zamudio/Derio, Vitoria-Gasteiz or Donostia/San Sebastian campuses.



## Set out your idea to convince us that the Park should implement your CHALLENGE

#### **HOW TO TAKE PART**

Anyone who would like to take part must submit their IDEA(s) before the deadline, using the online web form. Each person may submit as many IDEAS as they want, but they must use a separate form for each one.

Proposals must be based around the following criteria:

• Level of detail and development of the proposal presented:

- Scope of the proposal
- Planning of the implementation phases
- Estimated resources needed to implement the proposal
- Economic and technical feasibility and in terms of resources for possible implementation at the Basque Country Technology Park
- Relevance to and impact on the Park's strategy, companies and people
- Relationship and commitment to SDGs and RIS3
- Quality of the proposal. Details included, and thoroughness of the writing and information provided, background information consulted, submission of models or prototypes, originality, etc.



Ideas must be submitted through the online web forms provided for this purpose:

#### FORM FOR IDEAS

The deadline for receiving proposals is January 31, 2025

Any proposals submitted after this deadline will not be accepted.

#### **GENERAL TERMS AND CONDITIONS**
